INSTRUCTIONS

The State of Ohio requires residential rental property owners to register their rental properties with the County Auditor. Residential Properties include real property, one or more dwelling units leased or rented solely for residential purposes, or a Mobile home park or a site where lots are leased for parking mobile/manufactured homes/RVs for residential purposes. This regulation does not pertain to hotels or college dorms.

Section A. If you are an individual owner or Sole Proprietor, please include your full name. If a Partnership, Corporation or Trust, please include the name of the entity as well as the name of the corporation officer. Phone refers to the primary contact phone number for the property.

Section B. The State of Ohio requires that if the owner resides outside of the State of Ohio, the owner must designate an in-state Agent. The agent must be at least 18 years of age and reside in the state of Ohio. Again, the primary contact phone number should be included.
